A local law of the County of Yates, Providing for Real Property Tax Exemption

Local Law No. 3-73 Sec. 5 (a) as last amended by Local Law No. 2-1977, is hereby amended to read as follows:

Section 5. Limitations on Exemption

No real property shall be entitled to the exemption granted by this Local Law.

(a) If the income of the owner or the combined income of the owners for the income tax year immediately preceeding the date of making application for exemption exceeds the sum of \$5,500.00. Income tax year shall mean the twelve month period for which the owner or owners filed a federal personal income tax return, or if no such return is filed, the calendar year. Where title is vested in either the husband or wife, their combined income may not exceed such sum. Such income shall include social security and retirement benefits, interest, dividends, net rental income, salary or earnings and net income from self-employment, but shall not include gifts or inheritances.

This Local Law shall take effect on the 27th day of April, 1979.

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the City of having been submitted to referendum pursuant to the provisions of § 36 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special election held on 19 became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as Local Law No. of 19 of the County of, State of New York, having been submitted to the Electors at the General Election of November, 19, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative. 
